### Terms membership v.v. Harambee:

1. The undersigned declares to follow the liabilities arising from the membership as described in the Statutes and the Internal Regulations of volleyball association Harambee.
2. With subscription the undersigned agrees with the terms of a membership for a period of at least 6 months. In case, the undersigned ends his membership within 6 months after his subscription, a contribution fee for half a year will be charged.
3. Members should be in possession of a valid UnionCard / CampusCard and club extention ("verenigingsheffing") throughout the duration of their membership. Should the member in question neglect to adhere, Harambee will proceed to collect all resulting monetary costs from that member.
4. Members who are not a student of a university in the Netherlands or Saxion or are an employee of UT/Saxion, need permission from the board for their membership. This permission is based upon the Harambee External Members Regulation.
5. The authorization of the "SEPA Direct Debit" may be terminated at any time by a written declaration, with date and signature, addressed to the treasurer. This authorization does also end with the end of a member's membership.
6. Membership may only be terminated by written declaration, complete with date and signature, or e-mail addressed to the secretary.
7. The season ends on August the 31<sup>st</sup>. Should the mentioned declaration in term 7 have not been received at this time, v.v. Harambee automatically assumes continued membership throughout the following season.
8. If a declaration to terminate subscription happens to arrive after August the 31<sup>st</sup>, the member in question may be charged with the contribution for half a year.
9. By signing this document you approve that personal information is shared on the site of Harambee and you agree to the processing of his / her personal data for the execution of the membership.
